

AN ORDINANCE OF THE CITY OF GUNTER, TEXAS, AMENDING ORDINANCE 2018-10-15-01 RENAMING A PORTION OF STATE HIGHWAY 289/8TH STREET WITHIN GUNTER'S CITY LIMITS TO NORTH AND SOUTH PRESTON ROAD; RESCINDING ORDINANCE 2019-01-17-01; PROVIDING FOR SEVERABILITY, SAVINGS & REPEALING CLAUSES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Gunter, Texas ("Gunter") has initiated a request to rename a portion of State Highway 289/8th Street within the Gunter city limits to Preston Road (see **Exhibit "A"**), in Gunter, Grayson County, Texas; and

WHEREAS, on October 15, 2018, the City Council of Gunter, Texas ("City Council") adopted Ordinance No. 2018-10-15-01 renaming said portion of State Highway 289/8th Street within the Gunter city limits to Preston Road; and

WHEREAS, the City Council has investigated into and determined that it will be advantageous and beneficial to Gunter and its inhabitants to clarify that portion of State Highway 289/8th Street within the Gunter city limits that shall be renamed to North Preston Road and South Preston Road, as set forth below.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GUNTER, TEXAS:

SECTION 1: Findings Incorporated. The findings set forth above are incorporated into the body of this ordinance as if fully set forth herein.

SECTION 2: Renaming State Highway 289/8th Street. It is the intent of the City Council that the portion of State Highway 289/8th Street within the Gunter city limits is hereby renamed to North Preston Road and South Preston Road with the division between the two designations to be at the intersection of Preston Road (SH 289) and Main Street (FM 121). All ordinances and plats of Gunter referring to SH 289/8th Street, within the Gunter city limits, are amended to North Preston Road or South Preston Road, respectively; and said ordinances and plats shall otherwise remain in full force and effect. The general location of the street name change is described and depicted on **Exhibit "A,"** attached hereto and incorporated herein for all purposes.

SECTION 3: Ordinance No. 2019-01-17-01 Rescinded. Ordinance No. 2019-01-17-01 is hereby rescinded in its entirety.

SECTION 4: Severability. Should any section, subsection, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. Gunter hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional or invalid.

SECTION 4: Savings/Repealing Clause. All provisions of any ordinance in conflict with this Ordinance are hereby repealed to the extent they are in conflict; but such repeal shall not abate any pending prosecution for violation of the repealed ordinance, nor shall the repeal prevent a prosecution from being commenced for any violation if occurring prior to the repeal of the ordinance. Any remaining portions of said ordinances shall remain in full force and effect.

SECTION 5: Effective Date. This Ordinance shall become effective from and after its adoption.

Exhibit "A"

EXTENT OF AREA TO BE OFFICIALLY DESIGNATED AS
NORTH AND SOUTH PRESTON ROAD

All that certain area within the right-of-way of State Highway 289, also known as Eighth Street, within the corporate limits of the City of Gunter from the intersection with Main Street (State Highway 121) northward to Savage Road shall be designated as North Preston Road and all that certain area within the right-of-way of State Highway 289, also known as Eighth Street, within the corporate limits of the City of Gunter from the intersection with Main Street (State Highway 121) southward to Hunt Road on the east side and Wallace Road on the west shall be designated as South Preston Road, as illustrated on the attached map.
